

The Little Church That Could

Another fascinating house history that was unearthed during the 2013 edition of Century Homes Calgary was that of a home located at 1006 - 1 Street NW, directly across from Crescent Heights High School. From external appearances the subject appears to be a well-cared-for Edwardian gable-front two-storey; that observation however belies its historical significance. While this house's history doesn't have the same cachet that the tale of the Craftsman bungalow's murderess does-featured in last month's *Crescent View*- it comes with a pedigree steeped in the very annals of our community's history. And did I mention that there were ghosts?

To properly relate this story, it's necessary to go back to a time before Crescent Heights was even a village, thereby setting the stage for the appearance of this historic dwelling. So at the risk of alienating my faithful reader(s), who have no doubt committed all my previous articles to memory, I'll delve into some of those same articles for the requisite background.

These are the facts, Ma'am. In 1906, local entrepreneur A.J. McArthur subdivided one of his two quarter sections, that which was bounded on the north by 16th Avenue North and on the south by 8th Avenue, and then began selling acre lots to speculators who in turn parcelled them out and resold them. To the north, realtor J.F. Mitchell followed suit with his quarter



section due north of McArthur's. By late 1907, there were enough residents in these two quarter sections to petition the provincial government for village status. By that point, the city to the south had already annexed the lands south of 8th Ave North and the locals may have subsequently come to feel that village status might eventually provide them with a collective bargaining advantage.

And so it was that on May 1, 1908, Crescent Heights officially became a village.

By the early 1900's, A.J. McArthur and his wife Catherine had become prominent members of First Baptist Church downtown. But this dynamic duo couldn't help but see the many advantages of promoting a church "plant" in their own neighborhood. Accordingly, A.J.'s real estate office located in the south reaches of what is now Rotary Park, took on in the additional function in 1907 of a temporary residence for Reverend Doctor McLaurin and his family as well as that of a venue for Baptist Sunday School services. In furtherance of the cause, that same year McArthur set aside 3 building lots on the southwest corner of 11th Avenue and 1st Street NW, and arranged for the construction of a two-storey frame church on the property. He provided interim funding to complete construction, and once complete, the shortfall in building costs that could be raised via public subscription was covered by a third-party mortgage placed on the property. Title to the three lots remained in McArthur's name as the local church did not become a legal entity until later on, in 1909.

In 1910, McArthur became the MPP (now termed an MLA) for Gleichen, which riding included the village of Crescent Heights. His unforeseen death in 1911 at the age of 54 however, resulted in a legal boondoggle since the financial interests of his two sons, both minors, required the ongoing involvement of an Official Guardian, located in Edmonton. By 1910 too, local villagers had decided to petition the province for annexation, as the village couldn't efficiently provide access to the same municipal services as the city on their doorstep to the south.

And now back to our story about the first church on the North Hill. In late 1911, it became necessary for former pastor Fred Patterson to swear an affidavit to the effect that from 1907 on, prior to his demise, McArthur had been holding the church and land in trust for Crescent Heights Baptist Church. Once the provincial courts concurred, the three lots in question were then sold to the City of Calgary in conjunction with the sale of the other lots to the south in anticipation of future school development on the site, which wouldn't occur until 1928. Although it was consequently necessary to move the building off city property, it likely remained there for a time- with the City's forbearance- and continued to serve as a Baptist Church until its replacement, a new red brick building on the northeast corner of 11th Avenue and 1st Street NW, was completed in 1912. (Although an addition to the red brick building was completed in 1957, evidence of the 1912 structure can still be seen from the alley just to the north of the church.) Around 1912 too, the original 1907 frame Baptist Church had been moved to 1006 - 1st Street NW, and although it may have served as a manse for a short time, by 1914 the structure had attained its present status, that of a residential dwelling. The first resident in 1914, according to Henderson's Directories, was a realtor by the name of Archie McCannell.

But the house now at 1006 was much more than just the first dedicated church building on the North Hill. It had also served as a community hall when local residents first met in 1907 to petition for village status, and was initially the regular meeting place for village councillors to hold their meetings. One of the concrete achievements of the village council, which was empowered to tax residents, was the construction of a firehall just

north of 16th Avenue at 1st Street NW; after it had been completed in mid-1909, the much larger firehall would supplant the old frame Baptist Church (1006) as a meeting place.

Concurrent with Crescent Heights obtaining village status, local residents had also decided to form their own school district. Provincial approval for new school district 1768 was similarly granted in 1908, and not only did school trustees meet regularly for this purpose in the Baptist Church (1006 again), the building also hosted the first public school classes held in Crescent Heights, and on the North Hill too for that matter. Students were drawn from Rosedale, Sunnyside, Regal Terrace and Nose Creek as well as from the village itself.

The first teacher hired by the trustees was Miss Kate Lowry, at a salary of \$50.00/month; Miss Lowry would later go on to teach elementary school at Balmoral until 1948. Her first request was to have blinds installed on the three south-facing windows*, no doubt so that her sixteen charges wouldn't be unduly distracted while lessons were underway. By August 1908, it had become necessary for Miss Lowry to requisition a further eighteen seats, which would have made for a

crowded classroom indeed! The trustees were also on record in 1908 for contemplating proceedings against one Alfred Maberley, a prominent village resident and charter member of the local Methodist Church then being organized, for refusing to send his children to be schooled at the Baptist Church.

Local school trustees were fully aware that the housing arrangement at the Baptist Church was temporary, and plans were soon underway to construct a larger frame building, which had been built and occupied by September, 1909. The much larger 4 room schoolhouse- known for a time as the "White House", and later as the "Annex"- was located on property the board had purchased from realtor J.F. Mitchell. Its original site was just off 16th Avenue NW, on the north side, between 1st and 2nd Streets NW. Once the sandstone Balmoral School had been built in 1913, the White House was relocated to the NW corner of the property, where it remained for many years, at one time serving as an Industrial Arts shop. Although Balmoral School was initially shared by both public school students and Crescent Heights Collegiate, the senior students moved to Crescent Heights High School in 1928, upon its completion in its current location. Fast forward to the present, since some may have only stayed awake thus far in the hopes of hearing a ripping yarn involving ghosts! The home's present owners, who've lived here since 1989, report that the year they took possession (small joke) of the home, the conversation during Christmas dinner turned to that of ghost stories in derelict buildings. At some point during the discussion, a clamor arose from the staircase where it sounded as if an entity was noisily - Continued on page 9

When the work is completed, look for additions of the park's historic benches and additional waste receptacles around the perimeter of the park; upgraded crushed gray limestone pathways; and upgraded picnic tables. These improvements will allow our community residents to enjoy this well-kept community green space for many years to come.

Another planned upgrade to Crescent Park is the replacement of playground fixtures at its northwest corner. Although this facility was only originally installed in year 2000, the City has identified that the structures were constructed of chemically treated lumber, which may pose a health risk to children playing on and around them. Work is scheduled to start in earnest, as soon as the CHCA and the Calgary Parks Foundation can put together the details and funding resources for the project. Our board member, Kelly Grounds, has taken up the lead on this project and she has a number of activities for resident engagement and participation in the fundraising and installation of this project. Please contact Kelly Grounds if you are interested and/or are able to help in any way.

This past two months, the CHCA was approached by several agencies looking to develop social and affordable housing projects in our community. One proposal would see a multi-residential unit project to provide assisted accommodation for individuals who are at risk of being homeless in our city, while the other proposal would be an affordable housing, multi-residential unit project to provide subsidized rental accommodation to single women and single mothers. Although the CHCA is honoured that Crescent Heights is being selected for these projects, we are also concerned as to the additional number of residents this may bring into our community and the adherent lack of additional infrastructure and/or public amenities to handle such additional increase in density. We are proactively working with the many agencies to take an accurate assessment of how many such facilities are already located in Crescent Heights and to ensure that any proposed projects do not tip the delicate balance between a vibrant residential community and one which may over populate our community with inadequate amenities to support these additional residents.

Finally, the City is opening up additional opportunities for your input into the planning and development of transportation corridors in and around the city. Of definite interest to CHCA would be Centre Street, which is currently designated as a transportation corridor, which bisects Crescent Heights. Given that our recent suggestion to the Parks Department at the City to perhaps consider planting trees along Centre Street to help with developing a more pedestrian friendly streetscape was deferred to the folks at Calgary Transportation and Planning for their decision, the CHCA will be present at any of these events that would allow our input into the future development of transportation corridors in and around Crescent Heights. I am still hoping for some more trees and waste receptacles along Centre Street to make it a bit more pedestrian friendly, soon.

By the time this month's newsletter reaches your mailbox, the holiday season will be in full swing, and on behalf of my fellow board members at the CHCA, we wish you and your family a warm, healthy, safe and joyous holiday season, together with a happy and prosperous New Year!

descending the stairs and forcing its way through the front door. When the family rushed to investigate however, the damage was quite real; a demolished screen door and broken glass everywhere! No further such incidents have been reported. Given the diversity of occupants in this building since it was first built, it would be a bit of a poser to guess exactly which ghosts could have been involved in the manifestation described; you'd think there wouldn't be room in the house for too many more!

Since 1989, the current owners have raised three kids here, all of whom have attended the high school across the street. Earlier, from the years 1914 to 1989, the home had seen many residents; in the 1950's for instance, it operated as a boarding house, with men very properly occupying one level and women the other. As is the case with many Century Homes in our city, the house had also frequently sat vacant, and such was the case at the time of purchase by the present residents in 1989.

There are but a handful of homes remaining in Crescent Heights that would rate a historic plaque, but with the significant part it played in our community's formative years, this one is certainly at the top of the list!

*There are currently no windows on the north side of the house, which was once its south-facing elevation when it stood on the southwest corner of 11th Avenue and 1st Street NW. If one examines the old siding carefully however, the evidence is there that windows were in fact present at one time.

Crescent Park playground revitalization

At our October 9th CHCA board meeting City Parks representatives informed us that the Crescent Park playground (1101 – 2nd Street NW) was on their list for replacement. Each year there is only a handful of parks in the entire City area that are chosen to be replaced. The City uses a scale model of 1 (new) to 5 (Old/Does not meet Safety Standards) to determine the value of the park. CHCA was informed that the City had rated our Crescent Park at a 4. This rating was based on the facts that the existing park is wood and which is most likely treated with Chromated Copper Arsenate, or CCA (a toxic preservative), the bolts are badly rusting and it does not meet the current safety standards.

CHCA was encouraged to apply for The Building Playground and Communities Grant and the CFEP Grant. We are also accepting donations for the playground project and any donations we receive by December 15, 2013 qualify for matching funding by CFEP. All donations qualify for tax receipts.

Community engagement will start sometime in the New Year for playground design and feedback.

Community Planning Update: Imminent Arrivals

A recent circulation for another mammoth infill development proposed an attached garage with access off the rear lane, but the bylaw check revealed that such attached garages, even in the rear, are Not On. Members of the CHCA Traffic and Planning Committee in attendance could not recall having seen such a proposal before and wondered at the logic of the prohibition under the Land Use Bylaw. And indeed no less an authority than Calgary's former Director of Land Use Planning and Policy, Mary Axworthy, was unable to advise us on the policy rationale for the LUB's scotching of the rear-driveway plan. It was noted by committee members that the attached garage was accessed from the lane by a wide and long driveway and apron, suggesting that the stacking of as many as six vehicles as between the garage and driveway would have been possible. Yes I love living in the inner city and need parking for these six vehicles and perhaps a couple more on street.

Two back-to-back presentations to the committee on October 15 and November 5 herald the development of a pair of housing facilities that will advance the Calgary Homeless Foundation's Ten Year Plan to End Homelessness in Calgary. The first was presented by Louise Gallagher and Matt Vermunt of the Calgary Homeless Foundation, which proposes to develop a building to house 25 to 30 individuals in as many as 30 units. In a plan to leverage some provincial funds for new purpose-built facilities, the proposed units would require a parking relaxation and occupy a site on Second Avenue NE off Edmonton Trail, parcels currently occupied by two older homes zoned MC-2 on a combined 50 by 130-foot site. The cost to build the facility is currently estimated at \$150K per unit, and placement of residents in the units would be handled by a single social agency yet to be determined. If Hound's notes can be relied upon, the CHF owns and operates some 400 housing units in 22 properties in Calgary, which units have begun to give palpable form to its "Housing-First" Ten Year Plan. The proposal fits the "smaller model" in the range of facility sizes and is intended to house individuals rather than families. In addition to the individual units there would be a common area and on-site resident management.

On November 5 we were visited by Cindy Law, founder and principal of Avanti Housing, with a proposal to purchase an existing building of 14 units to house single women and single mothers who are moving out of abusive relationships through such agencies and the Sheriff King Home and Discovery House. Some clients may be new Canadians. The facility will not be a shelter or a halfway house, but a special care facility with a focus on vulnerable single women transitioning from short-term emergency shelter housing to a longer-term housing solution. Avanti Housing's proposal is also part of the Ten Year Plan to End Homelessness and will offer transitional support to its clients through continuing partnerships with other dedicated support agencies such as the YWCA, the Sheriff King and Discovery House. Placements at the facility will be made by one or more agencies, rents will be below market by 10 to 20 per cent and be aimed at a break-even level to meet the project's mortgage obligations.

Some few years ago, Crescent Heights was well represented in a lengthy and exhaustive review of the roles of Special Care Facilities in Calgary

and their relationship to the Land Use By-law; specifically through an inquiry as to whether Special Care Facilities did or did not belong in particular land use districts. I believe Crescent Heights was at that table in 2010 and 2011 as a result of our having been host to two special care facilities at opposite ends of the "spectrum" of such facilities: one being the Wing Kei Care Centre, the other the Mustard Seed's temporary Winter Emergency Shelter in the old Brick Warehouse building, which operated through the winter of 2006-2007 just prior to the building's demolition. This experience positioned Crescent Heights to speak knowledgeably and with some authority as to the different management needs for facilities at very different points on the operational continuum of Special Care Facilities (SCFs), and the relative expertise of agencies that operate them. One of the earliest, clearest and most forceful of the findings of the stakeholder group was that no land use district ought to be considered inappropriate to a SCF, but unlike older large-scale planning applications, no undue concentration of SCFs or non-market housing ought to occur, lest such concentration allow the repetition of well-documented past mistakes where such concentration led to social disorder or the "ghettoization" of non-market housing.

Perhaps it's a mere coincidence that these two Housing-First proposals should come to Crescent Heights so close in time to one another, but the discussion following the presentations was lively and covered a wide range of subjects: just how much non-market housing, offered by a range of agencies for a diverse client base, is already operating in the community? It was recalled that interest was high and the response of some residents was wary when the Calgary Housing Company's 20plus unit affordable housing building was proposed (and is now in the pipeline) for 15th Avenue NE. One other 12-unit addictions-based facility operates in the community. Do the two new proposals raise a question of concentration? Are there good-neighbour agreements sufficiently robust to ensure that social housing is a good fit in an established community? If the not-for-profit agencies that operate SCFs enjoy partial or full property tax abatement, does it undermine the community's tax base? If competent and caring agencies undertake to acquire and demolish negligentlymanaged slumlord properties in our community (of which there is an alarming number) and replace them with properly-managed facilities with on-site management and diligent oversight, might we not be far further ahead? Does the pace of low-density redevelopment at the high end, and a parallel development of additional non-market housing, tend to create a community of economic extremes?

We are already a remarkably diverse community, not least in respect of our economic diversity. Some of the most valuable residential real estate in the city sits a stone's throw from some of the most wretched and neglected housing stock to be found anywhere in Calgary. Crescent Heights always has been and always will be a welcoming community. It's going to be a test for our community as to how we receive and accommodate these currently proposed and future social housing projects. One wonders what they would make of them in Rosedale, Britannia or Eagle Ridge. As it was said of nations, can a community be judged the quality of its mercy? Will we open our doors or encircle our back yard with razor wire?

Snow Route parking bans

What are Snow Route parking bans and why do we need them?

Snow Route parking bans are temporary parking restrictions on designated routes that will be in effect for up to 72 hours following snow falls of five (5) centimetres or more. Snow Routes exist in all communities in Calgary, and include major roadways and most bus routes. Snow Routes have been marked by blue signs with white snowflakes —Watch for these signs in your community. Snow Route locations can be found at Calgary.ca/snow.

Snow Route parking bans are beneficial for a number of reasons:

- City crews will be able to remove snow from curb-to-curb on major traffic routes.
- Plowing times will be reduced by up to 30 per cent as plows won't have to navigate around parked cars. This will enable crews to get to residential routes faster.
- · Vehicles won't get plowed-in.
- Snow that builds up around parked cars will not get pushed back onto the road once they are moved.

Snow Route parking bans have been considered a best practice for years in most winter cities, including, Winnipeg, Toronto, Montreal and Chicago.

What this means for Calgarians

We need your support to make this program a success. You can help us make our roads safer and more driveable this winter by ensuring your car is not parked on a Snow Route during a parking ban. Become familiar with the Snow Routes in the areas where you live, work and visit. Be aware of the weather and understand that if you are parked on a Snow Route this winter and a parking ban is declared, you will have to find alternate parking.

If you are ever unsure if a parking ban is in effect, visit Calgary.ca/snow, tune in to local news or radio stations, or call 3-1-1 and listen to the automated Snow Route message.

Parking bans will be declared through a five-step process:

- 1. Snow event advisory If 5 cm or more of snow is forecasted, The City will issue a "Snow Event Advisory" through the media and online. This is meant to warn citizens that snow is expected and vehicles parked on Snow Routes will have to be moved.
- 2. Citizens move their vehicles Cars parked on Snow Routes should be moved as soon as possible.
- 3. Snow event declaration If there is an accumulated snow fall of 5 cm or more, The City will declare a Snow Event and Snow Route parking bans will be in effect for 72 hours.
- 4. Plowing Snow clearing operations will occur on Snow Routes for up to 72 hours after a parking ban has been declared.
- 5. Snow Route parking ban lifted The City will announce through the media and online when the Snow Route parking ban is lifted. Once the ban is lifted, citizens can park on the roads as usual.

Don't Let Thieves Steal Your Christmas

The Christmas season is prime time for car prowlers and thieves. Gifts and valuables in vehicles can make their jobs easy. **Here are a few tips to help reduce your risk:**

- When you exit or enter your parked vehicle, stop and take a look around the area.
- Before leaving your parked car, always remove the keys, roll up the windows and lock the doors.
- Park in a well-lit area, use parking lots frequented by others
- Put all valuables and gifts in your trunk. If that's not possible, conceal gifts and other valuables.
- Try not to unload gifts in your vehicle and then leave it unattended in the same parking spot. Car prowlers might be on the lookout for shoppers traveling back and forth from stores to unload gifts.
- · Never leave your car running unattended.
- If you park in an attached garage, always lock the door leading from the house to the garage and the garage door.
- If you don't park in a secure garage at home, don't leave gifts in cars overnight to keep them secret.
- After opening an automatic gate to underground parking, wait for the gate to close before you park.

- Inventory missing articles for later use with the police or an insurance claim.
- Report online at www.calgarypolice.ca/onlinreporting or in person at a district office. Even if there's little chance of catching the suspect, alerting the police can help prevent somebody else's car from being prowled.



Off the Shelf

Book review by Judith Umbach

The Singularity is Near, When Humans Transcend Biology



The book was published in 2005, which is fortunate for me because many concepts are more recognizable now they have moved into the mainstream. The exponential miniaturization of the last eight years helps the reader comprehend how computing power will be woven into clothing and other everyday items. The invention and improvement of cochlear implants points the way to ubiquitous support of human functionality by computers.

For decades computing power has been doubling every 18 months, known as Moore's law. This could be continued indefinitely by using or mimicking biological processes for accomplishing work. Kurzweil emphasizes that we won't need to replicate biological processes. Reverse engineering allows scientists to replace biological functions in ways that innovatively use available or invented materials. A basic



example can be recognized by comparing Icarus unsuccessfully beating artificial feathered wings and our flying fixed-wing aircraft made of strong metals and polymers.

Already we can see the use of information technologies to drastically reduce power consumption. This is why the tablet computers of today vastly outperform the desktop computers of only a decade ago. And, why today's cars consume less fossil fuel while providing more "information content", such as GPS and engine monitoring.

The "singularity" is the point at which technological change is so rapid that humans will not be able to comprehend its entirety. In effect, the human mind will be able to take advantage of computing power and memory without distinction between human and machine. According to Kurzweil, this will occur about the middle of this century. When I heard him speak a long time ago, the timeframe was 2020. Both now and then, rather than absolute predictions, I consider his ideas stimuli for my own thinking; nevertheless, he has an excellent track-record for predicting the future.

Licensing your cat or dog

The first step towards responsible pet ownership is to license your cat or dog. Here are five things every Calgarian should know about pet licensing:

- 1. Your cat or dog's licence is his ticket home! Licensing your pet provides Animal & Bylaw Services with the information needed to reunite you with your pet should he ever become lost. A licence tag also tells people who may find your cat or dog that the animal is owned and that they should turn him in to Animal & Bylaw Services.
- 2. Licensing your cat or dog is the law! Under the Responsible Pet Ownership Bylaw 23M2006, by three months of age, all cats and dogs residing in Calgary must be licensed with The City of Calgary Animal & Bylaw Services. The penalty for an unlicensed cat or dog is \$250.
- 3. Cat and dog licences must be renewed annually! A one-year licence costs:
- \$15 for altered cats and kittens (up to six months old)
- \$30 for unaltered cats
- \$36 for altered dogs and puppies (up to six months old)
- \$58 for unaltered dogs

- 4. Your licence fees, not tax dollars, fund our Animal Services operations! Your fees allow us to:
- Return lost cats and dogs to their owners and enforce the Responsible Pet Ownership Bylaw.
- Deliver school programs and educate animal owners about responsible pet ownership.
- Feed and shelter lost cats and dogs at the Animal Services Centre.
- Operate a state-of-the-art veterinary clinic to provide care for adoptable cats and dogs.
- Operate our animal adoption and volunteer animal socialization programs.
- Provide emergency medical care for lost cats and dogs that are injured.
- Help neighbours resolve animal-related conflicts.
- Provide free spay or neuter surgeries for the cats and dogs of lowincome Calgarians.
- 5. Purchasing and renewing a cat or dog licence is easy! You can purchase or renew a licence online (calgary.ca/petlicences), by phone (3-1-1), or in person at the Animal Services Centre (2201 Portland Street S.E.).

Thank you to all Calgarians who license their cats and dogs every year! Your commitment to responsible pet ownership helps us to create healthy, safe and vibrant communities for people and their pets.
