The 2008 River and Pathway Clean Up is scheduled for May 4th, from 10:00 am until 1:00 pm. Those of you who joined us last year will recall that our assignment was different from prior years: we tackled a good section of McHugh Bluff and made an excellent job of it. This year's assignment for Crescent Height has yet to be determined: we may be on the bluff again or we may regain our stretch of the Bow River from the curling club to Edmonton Trail. In years past we have met at the river's edge just below the pedestrian bridge to Prince's Island, but it occurred to me that a start at the Edmonton Trail end of our route might be a more logical starting point. We'll know more about our assignment once I've attended the annual orientation meeting on April 23rd.

As in past years, we are strictly limited to individuals ages 12 and up, and youngsters from 12 to 16 must be supervised and have a parent's written authorization. We also need the names,

contact numbers and signatures of all volunteers. Call me and I can get you signed up in advance or we can see to the paperwork on the day of the event.

Things to bring include leather gloves or good gardening gloves, sunscreen and insect repellent. Sensible shoes or hiking boots are in order. The organizers provide all the required supplies by way of garbage bags and bags for recyclables. There is a free breakfast the morning of the event beginning at 8:30 am. If you wish to attend the breakfast, let me know by April 25th and I will make sure you're expected. They need to know how many to plan for.

Naturally, the more people we have on the bluff or on the riverbank on May 4th, the quicker the job will be completed to better our very own piece of the Bow or the bluff that helps define our community.

President's Notebook

This month we welcome Elizabeth Hancock as our new Crescent View Editor. Many of you will have seen the posting in the March issue of the View and received our community e-mail regarding the vacancy. Elizabeth is eminently qualified, and has met with Communications Director George Day and our outgoing View editor Glenna Blackburn to get a feel for the nature and scope of the editor's role. I can attest to Elizabeth's dedication to getting the View out, as she has been the person for the last several years who has dropped off my bundles of the newsletter each month so I can deliver my few blocks' worth of View copies. We extend a warm welcome to Elizabeth in her new position.

Of equal importance is our sincere thanks to Glenna Blackburn, who has steered the View through the rocky shoals that can be the lot of even the most modest community newsletter. Glenna took over the editorship just around the time we moved the publication to Flexys Systems. She has been a steady hand and an iron fist, but has sometimes kindly indulged View contributors who have not always been mindful of the monthly deadline of the 15th for submissions (me, for example). I would have hoped that I could have made the deadline for this issue at least, but as I write this on March 15th I know already that it will be tomorrow before I finish up with it. Thank you Glenna for your many years of dedication in giving Crescent Heights residents a voice through our very own newsletter. I hope you'll find time to write an item or two in the future, and I know you will work effectively with Elizabeth through the few months' transition. Thanks to you both!

I've felt a little like Dr. No in recent weeks, as the CHCA Board has had to decline a couple of initiatives proposed by community residents. A member of the martial arts group that meets two weekday evenings in the Hall wrote to outline the problems that arise for their group with the cold hard concrete sub floor in our building. Several of our board members made inquires about various options, but it turned out that the existing floor, resurfaced just a few years ago, is the best multi-purpose surface, even though it isn't ideal for athletics. Other concerns included the higher level of maintenance that a more forgiving floor

might require, as well as the fact that our spending is dictated to a certain extent by the 2006 Lifecycle Study, which we finalized and received just last year. The report is a beauty. It maps out the future requirements for maintenance and repair of our facility's materials and systems, and constitutes a detailed roadmap through the ongoing repair, refitting and maintenance of our pretty little hall through the year 2031. Moreover, having just resurfaced the floor in 2004 (I believe it was '04), freeing up restricted funds or accessing grant monies for a refit of the floor is a tough sell to our funders. That said, I was sorry indeed to have to convey the board's decision to the community members who proposed it.

In other news regarding the Hall, the outdoor upper deck that overlooks Crescent Park, the mountains and the city, was also identified in the lifecycle for replacement. Based on some similar resurfacing of a deck we did at home a couple of years ago, I did some very rough arithmetic and hoped we could get a quote on the deck under the single-quote cost threshold in time for the March 3rd deadline for the current round of Capital Conservation Grants. But the cost will be higher than the single-quotation threshold, so we'll have to obtain a second quote, compare the two, and then decide whether to go ahead without grant funding or wait until we can qualify for a later round of CCG funding. My own thinking is that there are sufficiently spongy places on the upper deck that we should proceed sooner rather than later, even if we have to forego the matching grant from the City.

And speaking of the City, we have just said a fond goodbye to our Community Recreation Coordinator Karina Damgaard, who has taken on a new position with the City. We welcome our new CRC, Amanda Turvey, even as we thank Karina for her several years of helping us negotiate through City services, resources and programs. We wish Karina all the best and look forward to working with Amanda in the coming months.

Thanks are also due to Marlene Zaharichuk, our facility booking

goddess, who steered us in the direction of Air Condition and Mechanical Services Limited, who spent some quality time in our building late last year and again this past February. The same lifecycle study I referred to above had noted some deficiencies with the heating and make-up air system. The verdict of the lifecycle study was to replace both downdraft furnaces and repair the bearings on the make-up air system that exhausts warm air and draws in cooler outside air in the warm weather season.

The full high wall of south facing windows that is such an attractive feature of our Hall certainly lets the sun pound in, and the make-up air system hadn't been functioning properly in recent years. After a couple of days of TLC, AC&M has given our furnaces a clean bill of health and a forecast for a good many years of service to come. The service work is money well spent, we think, because it restores our systems to good health and allows us to defer an expenditure of about \$12,000 for new furnaces. Thanks to Chris Rucki and his talented technicians.

Here and there around the community, we can update you on a few other activities and initiatives:

- I attended what I hoped would be the final meeting of stakeholders reviewing planning and land use principles governing the location and operation of the full spectrum of Special Care Facilities, from group homes to halfway houses to additions treatment centers and emergency shelters. The consultant's report has gone to Calgary Planning Commission in March and will go to City Council on April 14th. As a community that was involved in vigorous discussions surrounding two very different special care facilities to locate in our community, we were fortunate to have been involved in the discussions and have input into the report and recommendations. It seems a couple more meetings are in order to ensure the next steps are precisely the ones residential communities and the care agencies who deliver the services want to see taken.
- Joe Nagy and I attended MP Jim Prentice's Breakfast with the Community Presidents on February 23rd. This was the second such breakfast, and was a good opportunity to see how the federal government

actually connects at the community level. Sometimes they seem so very far away and removed from the day to day life of communities, but Jim Prentice continues to maintain substantial connections with the communities of Calgary North Centre (but probably his closest connections are with us in Crescent Heights, where Jim is a resident). Thanks for the breakfast!

Finally, as spring approaches, planning has commenced for our April Annual General Meeting. My Notebook of last month indicated that the AGM is slated for April 21st, but recent developments indicate that we may have to reschedule in order to ensure our audited financial statements are ready for presentation.

On March 10th we received a letter from the City of Calgary to the effect that its Audit Committee would be reviewing the financial statements of all not-for-profit organizations operating facilities on City-owned land. That includes us of course, and although we normally prepare our materials for audit at this time, many other organizations, who have different financial year ends or reporting schedules, will likely have to meet this same late April deadline. What this may mean is a stampede of organizations rushing to deliver their materials to the Federation of Calgary Communities' audit program. As always, it's first come first served, and although we are in good shape, we won't know for a few weeks if our audited financial statements will be ready for the April 21st AGM date. We will keep you posted by our regular channels and hope to be able to go ahead as planned on April 21st, but the presentation of our annual audited financial statements is really the cornerstone of our AGM. Without the audit complete and ready for presentation to our membership, it's just another wine and cheese social.

That said, I can advise all our members that the CHCA is currently in a stronger financial position than ever before, but you don't need to take my word for it: the best measure of an organization's financial health is the rigor of a formal audit.

Happy Spring everyone. We hope to see you in April as planned for a glass of wine, a nibble of cheese and a watershed financial update.

Letter from the Editor

After six years of having the honor of writing and editing *The Crescent View*, I would like to sign off in a flourish by remembering those stalwart souls who came before me and by taking you back to remember how far we have come as a community.

When I took over the reigns late in 2002, Isabelle Jankovic and Elsie Ross were the dynamic duo behind the *View*. Not only did they do the actual layout, using a program called PageMaker, they brought new business advertising to the newsletter, collected the money for the ads, and initiated many new ideas including the inspiration of writing restaurant reviews. My job was relatively simple – I would simply edit the articles received, write some of my own, and submit them to our publisher for her to do the layout. Sounded good to me.

Since taking over the reigns, there have been two community presidents, a host of new board members and sub-committees, and many new folks moving into our established community with their families. There have been new homes built, road improvements made in the way of traffic calming, and an excellent focus on our community urban forest. Residents have taken advantage of 'free' trees, provided by the City, for our boulevards and we are now rewarded, through our diligence, an exceedingly high level of communication with the City in regards to hearing our concerns on planning and other major issues that affect each and every one of us.

McHugh Bluff restoration was first

presented to the community in October 2003, our first casino volunteer night was held (the last one being 1996!), the highly coveted Ken Shedden Architectural Award was incepted, and the Christmas Family Potluck was a huge success which has since become a neighborhood tradition and is loved by all.

Centre Street streetscape (or lack thereof) was a topic of conversation in early 2004 and dearly needs to be a topic again, the ubiquitous Blue Parrot has been transformed into Big Fish and is wildly popular, reeling in content community residents to its lair. Lombardo's was re-morphed as Piato and then re-morphed again as Open Range. We also have our own community baker, thanks to the Urban Baker, and many more great places to eat than we ever had before.

2004 also brought community awareness to a distinctively high level with news of 16th Avenue revitalization planning and the First Annual Crescent Heights Garden Tour grown from seed remains a popular perennial attraction. Another first was the Fancy Dress Bocce Tournament, held in the snow, which was followed by the Bratwurst and Beans Festival, which has now become the Bratwurst, Beans and Lantern Festival. The very popular Historical Tours were also new for 2004, our community had a brand update with a new sign and letterhead created and the babysitting co-op was started and is still in full swing. On top of it all, the newly proposed Wing Kei Care Center was an unusually large ripple added to our normally still pond.

2005 brought about the inception of the



new Rotary Park Playground by a sub-committee of dedicated parents who envisioned a newer, more interesting and safer playground for our children, relatives and guests. Many hours were dedicated to this project and it is something impressive we can all be proud of.

2006 saw another volunteer resident reaching out to other parents with kids as the illustrious Playgroup was born and is still growing strong, our Plains Cottonwood tree was give the distinctive status of a Heritage Tree and although an uproar ensued from both sides of the issue, the Brick was transformed into a temporary emergency homeless shelter.

Jump to 2007 and the City plans for a new Emergency Operations Center (EOC) generated much interest from residents. Everyone was concerned about the new footprint and how the existing lawn bowling facility would be affected. After community urged consultations, ground breaking is due to start this summer. Our rather elderly Community Hall has enjoyed increased attention as the monies from the yearly casinos allow us to refurbish it to new standards, in hopes for more rental income to add to our bottom line.

Reflecting back on the years, it is interesting to see what has transpired in our community. Living as we do from day to day, we rarely see how we arrived at where we now are. It is comforting to know that our community is strongly focused on tradition and family and that our sense of pride in our homes and our welcoming of new neighborhood friends into our circle will keep us all going forward in the coming years.

It is in this happy space that I hand over my pen to Elizabeth Hancock. Elizabeth will, so to speak, carry the pen for growing our community newsletter into something just a little bit more throughout the next few years. I wish her all the best and sincerely thank you for your support during the last six years.

Plan It Calgary

Who is the author? We should reference name as they refer to themselves in the first person.

I had the opportunity to attend the Plan it Calgary community consultation on March 3rd. The Plan it Calgary project is expected to be completed by the end of 2008 resulting in a long term land use and transportation plan for the City.

Plan it Calgary drew upon imagineCALGARY for its inspiration and followed the Sustainability Principles, which were adopted by City Council, for land use and mobility. The aim of the project is to determine how additional growth of 1.3 million people over the next 50 to 70 years would be dealt with.

The objective of Plan it Calgary was to project this growth against three different scenarios:

- **Dispersed Scenario** – where growth continues much the same as today. It assumes most of the new housing will be accommodated on the edges of the city with marginal redevelopment in key areas near LRT stations and along commercial corridors. It only supports the sustainability principles modestly.
- **Compact Scenario** – assumes no additional land is used for urban expansion. New population would be completely absorbed within the existing urban footprint. It is expected this

scenario is likely to impact existing single family homes with most of the redevelopment occurring in older areas.

- **Hybrid Scenario** – is a combination of Dispersed and Compact where 62 percent of the new population and 92 percent of new jobs would occur within the current footprint. There would be some expansion at city boundaries, but where the city is built on a grid, greater opportunities would exist to create concentration.

The direction the City chooses to grow will have a significant affect on greenhouse gas emissions, transportation choices and infrastructure, location of jobs, shopping and amenities. Between 2003 and 2005, Calgary's footprint grew by about 2000 acres per year: approximately 5.5 acres per day. Increasing densities are necessary to reduce the rate the city expands at its edges.

The Plan it Calgary group is presenting their recommendation to Council in April. It is my understanding that they are expecting to recommend a modified version of the Hybrid scenario. If you would like more information on this project you can go to: <http://www.calgary.ca/planit>.

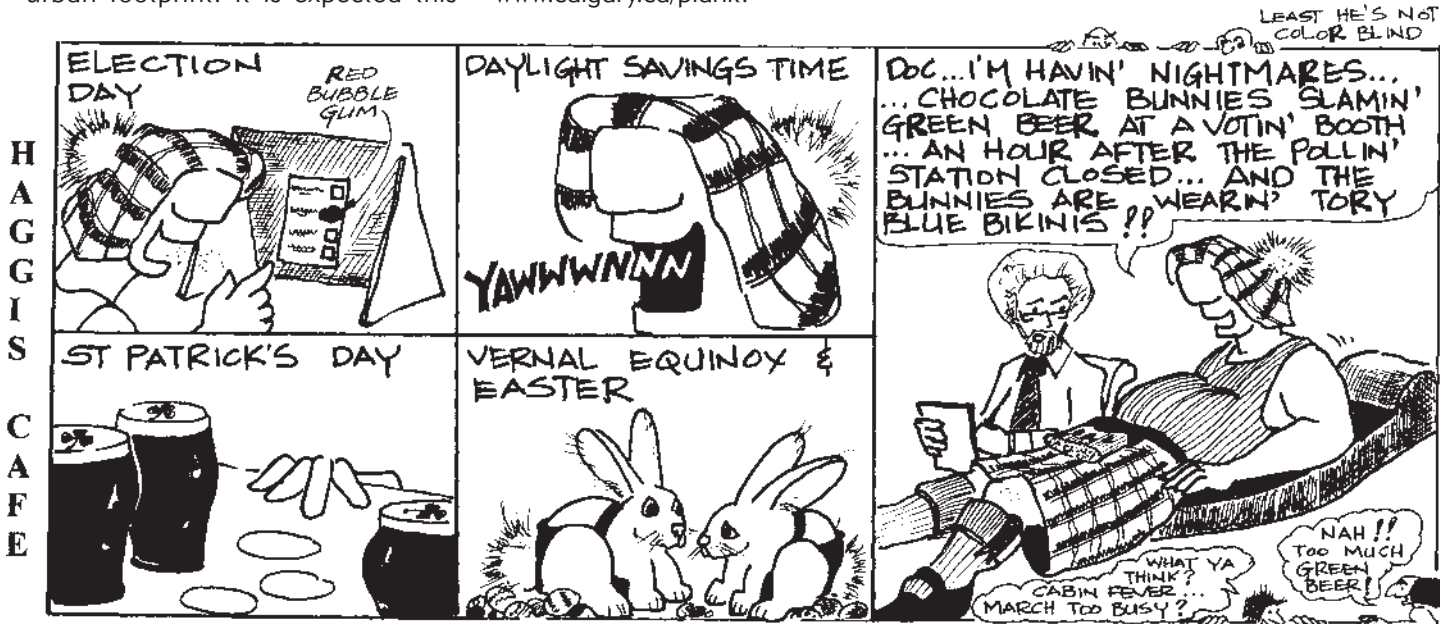

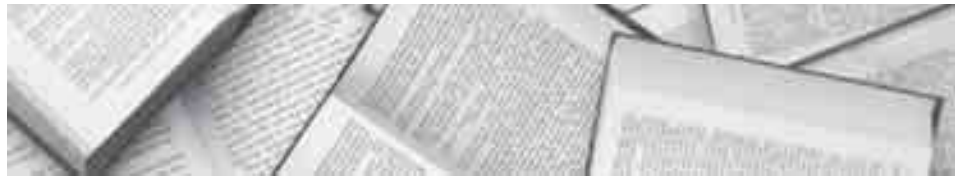

Spring Cleanup!

When the promise of spring is in the air, many Calgarians think about cleaning and organizing their garages, basements and yards. Here are a few important bylaws to guide you through this annual ritual:

- In your backyard there can be no accumulation of loose garbage, bottles or cans, household furniture or goods, automobile parts, equipment or appliance parts, yard waste including grass, tree cuttings visible from outside of your property.
- Materials that create unpleasant odours or attract pests are prohibited from being stored on private property. This includes animal parts and feces.
- Property owners/occupants are responsible for maintaining and keeping tidy the back of their property up to the middle of the alleyway.
- Chemical waste, oil, batteries and oversized items will not be accepted if left out for garbage collection.
- Garbage should be set out for collection no earlier than 7:00 pm the night before and no later than 7:00 am on the morning of your collection day.
- Garbage bags or containers and their contents must weigh less than 20 kg (44 lbs) and bundles can not be longer than 1.25 m (4 ft) in length.
